- f. The Agro-processing Plant in Green Hill to add value to our ginger, eddoes, plantain and other agricultural produce and;
- g. The comprehensive road repair program specifically those roads in the area referred to as Back Road in Old Montrose, just beyond Starlift Steelband Room and on both sides of the forked road.
