**2026 ESTIMATES OF ST. VINCENT & THE GRENADINES**

To be moved by the Honourable Dr. Godwin Friday, Prime Minister/ Minister of Finance.

**WHEREAS** section 70(1) of the Constitution of Saint Vincent and the Grenadines provides that the Minister for the time being responsible for finance shall cause to be prepared and laid before the House of Assembly before, or not later than thirty days after, the commencement of each financial year Estimates of the Revenues and Expenditure of Saint Vincent and the Grenadines for that financial year;

**AND WHEREAS** section 70(2) of the Constitution provides for the approval of the Estimates of Expenditure by the House;

**AND WHEREAS** the Government had additionally decided to prepare Estimates on a triennial basis:

**BE IT RESOLVED** that this Honourable House do adopt the Estimates for the financial year ending 31st December, 2026;

**AND BE IT FURTHER RESOLVED** that this Honourable House note the projections for the financial years ending 31st December, 2027 and 31st December, 2028.

**RESOLUTION**

TO BE MOVED BY THE HONOURABLE DR. GODWIN FRIDAY, PRIME MINISTER/ MINISTER OF FINANCE:

**BE IT RESOLVED** that this Honourable House do authorize the Minister of Finance to borrow by means of fluctuating overdraft or otherwise from the First National Bank Limited, or the Republic Bank, or the Bank of St. Vincent and the Grenadines, money to an amount not exceeding in the aggregate eighty-five million dollars, during the period 1<sup>st</sup> January, 2026 to 31<sup>st</sup> December, 2026 for the purpose of meeting the current requirements of the Government.
